MOOT ROUND MATCH GUIDELINES

Determining the winner of a match

In any given match, the Team receiving the greater number of Round Points wins the match. If the two Teams have an equal number of Rounds Points, the Team with the higher Team Raw Scores wins the match. If the two Teams have an equal number of Round Points and an equal Team Raw Score, the match is a draw.

Determining the team progressing into the next round

Preliminary Round to Quarter-Final Round:

The top 8 teams, determined by the number of wins from the Preliminary Round, will proceed to the Quarter-Final Round. Teams will be ranked from 1 to 8 based on number of wins (in descending order).

In the case of a tie, the team with the higher accumulated Total Round Points in the Preliminary Round will be ranked higher. In the case that the tie is not broken, the Team with the higher Total Raw Score from the rounds shall be ranked higher. *

Quarter-Final Round to Semi-Final Round:

The top 4 teams, determined by the number of wins from the Quarter-Final Round, will proceed to the Semi-Final Round. Teams will be ranked from 1 to 4 based on number of wins (in descending order).

In the case of a tie, the team with the higher accumulated Total Round Points in the Quarter-Final Round will be ranked higher. In the case that the tie is not broken, the Team with the higher Total Raw Score from the rounds shall be ranked higher. *

Semi-Final Round to Final Round:

The top 2 teams, determined by the number of wins from the Semi-Final Round, will proceed to the Final Round. Teams will be ranked from 1 to 2 based on number of wins (in descending order).

In the case of a tie, the team with the higher accumulated Total Round Points in the Semi-Final Round will be ranked higher. In the case that the tie is not broken, the Team with the higher Total Raw Score from the rounds shall be ranked higher. *

The team ranked higher will be given a choice to moot either as Claimant or Respondent in the Final Round.

* In the event, at any round, the methods of breaking the tie are unsuccessful, the Competition Administrator shall determine the next best method to break the tie.
