

Austen Pereira

MOOT JUDGES

The Hon. Justice Brian J Preston AO FRSN SC

Justice Preston is the Chief Judge of the Land and Environment Court of New South Wales. Prior to being appointed in November 2005, he was a senior counsel practising primarily in New South Wales in environmental, planning, administrative and property law. He has lectured in post-graduate environmental law for over 30 years. He is the author of Australia's first book on environmental litigation and 164 articles, book chapters and reviews on environmental law, administrative and criminal law. Justice Preston is an Official Member of the Judicial Commission of NSW, Fellow of the Australian Academy of Law, Fellow of the Royal Society of NSW and Honorary Fellow of the Environment Institute of Australia and New Zealand. He was awarded a Doctor of Letters (honoris causa) by Macquarie University in 2018 and a Doctor of Laws (honoris causa) by Western Sydney University in 2022. He is Vice President for Oceania of the Global Judicial Institute on the Environment and Chair of the Environmental Law Committee of the Law Association for Asia and the Pacific (LAWASIA). Justice Preston was recognised with the Award for Excellence - Outstanding Contribution to Environmental Law by the Law Council of Australia's Legal Practice Section in 2021. In 2023, he was awarded the Medal of Honour by the World Jurist Association at the United Nations in New York and was granted Life Membership by LAWASIA. He was appointed as an Officer of the Order of Australia (AO) in the Australia Day Honours List 2025. Justice Preston is currently a Visiting Professor at Durham University (UK), an Adjunct Professor at three Australian universities, the University of Sydney, Western Sydney University and Southern Cross University, and a former Visiting Fellow at Corpus Christi College and Magdalen College at Oxford University (UK).

Aditya Kumar Choudhary

Mr. Aditya Kumar Choudhary is a distinguished Advocate with nearly three decades of professional practice before the Hon'ble Supreme Court of India, the Delhi High Court, and several other High Courts and Tribunals across the country.
