ADDITIONAL CLARIFICATIONS

1. Is Reyna a party to the New York Convention?

No.

2. What is the position of Ms Jeon who escalated Luna's disappearance to Aurora's Head of Operations?

Ms Jeon So Hee is the group manager of ECLIPSE.

3. Following Luna's disappearance, when was the emergency meeting between Aurora and Nova held?

5th February 2026.

4. When was the Zoom meeting referred to in paragraphs 31 and 32 of the Moot Problem held?

5th January 2026.

5. What is the extent of adoption of AI technologies among other R-Pop companies?

A recent R-Pop industry report indicates that most R-Pop companies, regardless of size, are progressively integrating AI technologies into idol training, following Aurora's success. However, the report does not indicate whether such technologies have been deployed to enhance concert performances.

6. Whether Nova is facing any other legal actions for the rumoured delayed or non-payments to other entities?

No litigation involving Nova in relation to the alleged delayed or non-payments has been reported. It cannot be ascertained whether any related disputes have been referred to arbitration, given the confidential nature of such proceedings. However, there is a news report indicating that Nova has been served with a letter of demand from a former C-suite employee for alleged breaches of contract, with further details yet to be disclosed.

7. Did Aurora apply for security for costs in relation to the jurisdictional challenge only, or the entire proceedings?

The security for costs application was not expressly confined to the jurisdictional challenge.

8. On what basis was the stay of proceedings pending arbitration granted?

The Reynan High Court granted the stay in the exercise of its discretion to avoid parallel proceedings. In delivering its oral judgment, the Court also cited the principle of *kompetenz-kompetenz*.

9. In relation to prior collaborations between Nova and Aurora, did the agreements consistently include a standard form dispute resolution mechanism?

All six collaboration agreements contained arbitration clauses providing for arbitration under the AIAC Arbitration Rules. Four out of the six agreements also required prior negotiation as a pre-condition to commencing arbitration.

10. Under what procedural rules was the prior mediation between Nova and Aurora conducted?

The AIAC Mediation Rules.

11. Does Nova have any ongoing or upcoming projects with other entertainment agencies at the time of the current arbitration proceedings?

Yes. Nova, as a leading player in the industry, has several ongoing projects involving major artists and entertainment agencies. Details of Nova's upcoming projects and performances are also publicly available on its official website.

12. What is the *lex arbitri* for the arbitration?
